Corruption is when people who work for the government do the wrong thing.


The word corruption can mean:




- not telling the truth
- doing things that don't help the community
- breaking the law
- stealing money or goods
- using your job to get benefits, like taking money to do something illegal.



We say people who work for the government are in the public sector.



Different types of people work in the public sector



- government staff
- judges and people working in the court
- council workers.





Our job is to make sure there is no corruption in the public sector in Victoria.

You can report corruption to IBAC and we will:



- keep your information safe and private
- investigate the report
- help find solutions.

This fact sheet is about Victoria Police.



People who work in Victoria Police are called police personnel.

Some police personnel are:



- Victoria Police officers
- Victoria Police recruits
- Protective services officers (PSOs)
- Police custody officers (PCOs)
- Victorian public service employees (VPS).



IBAC makes sure there is no misconduct in Victoria Police.






#### What is misconduct in Victoria Police?


Misconduct in Victoria Police is when police personnel do the wrong thing.


## What are some examples of misconduct in Victoria Police?



Some examples of misconduct in Victoria Police are:







- giving out information they are not allowed to give out
- doing paperwork incorrectly
- using government money to do things they are not allowed to do
- stealing
- seeing misconduct and not reporting it.







If you see misconduct and do not report it that is also a form of misconduct.





Anyone can make a report to IBAC about

misconduct in Victoria Police.

Who can make a complaint about misconduct in



Victoria Police must tell IBAC if they receive a complaint about misconduct.

### What will IBAC do when we get a complaint about misconduct?



IBAC will review the complaint and decide what needs to be done to solve the complaint.

IBAC will decide to:



- look into the complaint in more detail.
- ask Victoria Police to find a solution.
- not do anything more if there is nothing else that needs to be done.



The person in charge of Victoria Police is called the Chief Commissioner.


If IBAC ask Victoria Police to find a solution, the Chief Commissioner must report the result to IBAC.

What can you do if you see misconduct in Victoria






You should tell IBAC about any activity that does not seem right.
